## The role

Teams will work together at each stage of the patient journey, supporting them as they arrive (Early Days in Custody Team), delivering the care they need, promoting good health and supporting resettlement (Planned Care Team) and responding to urgent and emergency needs (Unscheduled Care Team). Whatever your clinical interests and experience, this role will enable you to use and develop your skills and provide opportunities to expand your scope of clinical practice.

Regardless of what team you'll work within, you be part of a multi-disciplinary team providing the wealth of experience you have in your subject field.

Working as a prison Substance Misuse Recovery Worker, you will working with other members of the team that you are part of, assessing needs of patients and assessing risks accordingly. Whilst undertaking your role, you will:

**Provide outstanding evidence based care to a case load of psycho social patients seeking out,** listening to and acting on their feedback so that care is personalised and informed by what matters to them. You will provide a programme of psycho social interventions, along with information and advice on substance misuse, alcohol, smoking cession, blood borne viruses and safe sex practices.

**Deliver** non-judgemental care on a one to one basis and through group work, supporting the nursing and pharmacy teams in primary care within healthcare centres and on wings and house blocks. You'll make a real difference as defined throughout our bespoke HiJ competency framework following our policies, procedures and always considering safeguarding.

**Inspire** excellence by forging strong links within our teams, our partners and stakeholders and providing a service that people can trust, feel safe within and feel proud of.



**Promote** best practice, using evidence based care and continuous quality improvement embedding a culture of shared learning. You will promote patient wellbeing, demonstrating empathy and understanding to our patients.

**Share** knowledge and skills to ensure safe care and support each other to do a great job engaging with the process of reflection and supervision.
